#### PARTNERSHIP AGREEMENTS

# From The Laws of Duplicate Bridge 2007

# Law 40 A. Players' Systemic Agreements states:

- 1 (a) Partnership understandings as to the methods adopted by a partnership may be reached explicitly in discussion or implicitly through mutual experience or awareness of the players.
- **(b)** Each partnership has a duty to make available its partnership understandings to opponents before commencing play against them. The Regulating Authority specifies the manner in which this shall be done.

### Law 40 C. Deviation from System and Psychic Action states:

1. A player may deviate from his side's announced understandings always provided that his partner has no more reason to be aware of the deviation than have the opponents. Repeated deviations lead to implicit understandings which then form part of the partnership's methods and must be disclosed in accordance with the regulations governing disclosure of the system. If the Director judges there is undisclosed knowledge that has damaged the opponents he shall adjust the score and may award a procedural penalty.

# Although a psychic or "bluff" bid can be legitimate if it meets the requirements of Law 40 C 1(a) IT IS NOT ENCOURAGED IN OUR CLUB.

When a psychic bid turns out well for the player who psyches, the opponents are often very cross to say the least!

Frequently the psycher comes off badly, since partner, who is also fooled, can bid too high, double the opposition in an unbeatable contract, or take some other kind of suicidal action.

Psychic bidding undermines partnership trust and is rarely used by top tournament players.

At bridge ... friendliness is the best policy. Don't let the premium lapse! (Harold Levitt, Delaware U.S.A.).

Bridge is an enjoyable pastime at our club, Let us keep it this way.
