1. Lebensohl Convention - Friday March 15, 9.30 am

If your partner opens 1NT you all know what to do if holding the following:

a)	▲ 98	b)	♠ K J4
	♥ Q54		♥ Q54
	♦ K8764		♦ K98
	♣ KQ9		♣ Q973

Both hands will bid 1NT - 3NT. But what if there is a 2S overcall? Both hands want to be in game, but will 3NT be the right place? This problem and others (when there is interference over your 1NT opening) is solved by the lebensohl convention - a very handy tool to add to your toolbox.

2. Two-suited Overcalls - *Friday March 22, 9.30am* These are an efficient way of describing 2 suits with one bid. They are competitive in the battle for the part-score, making it difficult for the opposition to judge their correct level.

Please ensure that you record the *Date Out* and your *Name* when borrowing a book and then the *Date In* when it is returned.




For the history buffs there



MASKS OPTIONAL



As a director, I get called many times to deal with penalty cards on the table. It could be that - the wrong defender made an opening lead out of turn; a defender exposed one or more cards during play; a player exposed card(s) during auction and he/she became a defender; a defender simply forgot to follow suit. What about declarers I hear you say? Declarers can never have a penalty card.

Many players will know that a player with a penalty card must play it at the first legal opportunity. This means to follow suit, discard/trump (if the penalty card is a trump) or lead it to the next trick. The defender's partner is subject to lead restrictions if he/she is leading to the next trick when the penalty card is on the table. However, the above statement is not 100% correct. It is true if the penalty card is a **major** penalty card. Any card of honour rank (A, K, Q, J or 10), or any card exposed through deliberate play, becomes a major penalty card. If a defender has two or more penalty cards, they are all major penalty cards too. If the director deems a single card that is a 9 or below (not an Honour rank) is exposed unintentionally, he/she can designate it as a **minor** penalty card (Law 50B). What obligations does the owner of a minor penalty card have? Not many. The defender must play the minor penalty card if he/she wants to play a card of the same suit below the rank of an Honour. He/she is entitled to play an Honour card of the same suit rather than the minor penalty card instead. The defender's partner is not subject to lead restrictions if he/she is leading to the next trick (Law 50C).

Did you know that information derived from a penalty card (major or minor) and the requirements for playing that penalty card are authorised information for all players as long as it stays on the table (Law 50E1. Subject to E4)? Therefore, a declarer can play a deuce and force the defender to follow suit and win it with the penalty card Ace, or play an Ace and force the penalty card King under it, or a defender can follow suit with a small card so his/her honours do not crash with partner's penalty card. However, as a defender, this knowledge becomes unauthorised (i.e. you're not allowed to plan your play based on the knowledge that your partner has that card) once it returns to your partner's hand. The director can award adjusted scores if he/she deemed that you have (Law 50E2).

We now know that a player with a penalty card is required to play it in specific circumstances. Have you ever thought about what happens if he/ she fails to play it as required? The answer is: the player has committed a revoke! Let's check the definition of a revoke (Law 61A): "Failure to follow suit in accordance with Law 44¹ or **failure to lead or play, when able, a card or suit required by law** or specified by an opponent when exercising an option in rectification of an irregularity, constitutes a revoke." Hence a revoke can happen not just because you fail to follow suit, it can also happen because when the declarer requires you to lead a specific suit to the next trick as specified by the law but you do not comply (assume you have at least one of it).

However, a fact that may surprise you is that once the revoke is established, the director cannot award automatic trick adjustments, your typical one or two tricks transfer, here (Law 64B3). He/she can still assign an adjusted score if defenders have gained an advantage by not playing the penalty card when required (Law 64C). Having said that, when a session is under the control of a non-playing director, he/she will and should stay at the table until the penalty card is gone so as to make sure all the rectifications are followed and executed properly. I don't remember a revoke has been established under this circumstance before. Most of the time, players at the table will notice the failure to play the penalty card straight away.

1. Law 44 describes the basic rules of play: requirement to follow suit, what happens if you cannot (discard), what is a trick, definition of winning/losing a trick etc.

WHAT ARE THE ODDS?

Answer: 0.000017 or 17 chances in a million for a 10xcard suit.



East can count 10 playing tricks, so if the dealer would make a Game Force opening (usually 2C).

However South is the dealer and so when the bidding comes around to East, a direct 4H bid is correct and 10 tricks can be made.

However, the NS hands are interesting too! If South counts 7 playing tricks, then he/she could open 4C. Not vulnerable, this is a pre-empt expecting to go down 3 tricks (Rule of 2 & 3).

North has 3 sure tricks for partner and a possible 4th. Bidding 4D should show the 5+ suit and willingness to play in 5C. Over East's 4H South can show the D fit and bid 5D.

Interestingly this makes 12 tricks played

by North. Can you see how? And why South would only make 11 (if there was a way that the D's were bid first by South)?

However, North might bid 5C immediately. In this case East is sure to bid 5H, for one off.

Hand provided by Ronnie from a recent Novice session at Goulburn St. One pair was in 5C, 8 pairs were in 4H, 5H or 6H.
