## **COMMITTEE CRUMBS** – Meeting April 4, 2025

The Managing Committee met in the morning, near the coffee and donut bar – good coffee but no donuts available!

Even without that sugar hit a lot of business was dealt with:

- 1. **Technolog**y A new dealing machine has been ordered; the purchase of a better microphone is on hold; our computer will not be supported after October so closer to that time a new one will need to be purchased.

#### FROM THE CHIEF DIRECTOR

Our Club members are moderately good when it comes to alerting procedures, asking about the meaning of bids, and responding to questions about bids, but there is room for improvement in some areas...

#### **Alerting**

The ABF Alerting Regulations go into some detail on when you must alert and when you are not required to alert. If in doubt it is best to alert, but it is important to be consistent with your alerts, and to make them quickly (before your right-hand-opponent bids). A procedure to highlight that is not currently observed well in our Club (or generally around Australia) is section

• 7.4 Alerts are made by audibly saying "Alert" and, if bidding boxes are in use, an alert card should be placed across the relevant call.

Note the requirement to place the alert card across your partner's bid and to actually alert your opponents audibly – don't just silently place the alert card in front of you!

## Questioning

At your turn to act (and only at your own turn) you may request an explanation of the opponents' auction (Law 20F1), and you may ask specifically about the most recent call (Law 20F3). In either case you should ask a consistent neutral question such as:

- May I have a review of the Auction?
- What do you understand from your partner's Call?

For a call that has just been alerted you can abbreviate the second of these to just "Yes?".

Anything else is **Unauthorised Information** to your partner and may restrict their ability to make certain bids. For example, asking any pointed question such as "Does your 1S response deny four Hearts?" could restrict your partner from bidding Hearts. If an explanation is unclear you can, of course, ask follow-up questions (but your partner must wait for their turn to act before asking their follow-up question).

In general you should ask questions only if you need to know the answer in order to make your own call. It is expressly forbidden to ask questions for the sole purpose of benefiting partner or to elicit an incorrect response from your opponent (Law 20G).

It is often best to wait until the end of the Auction before asking for a review (which the best Declarers will often provide unprompted).

## Responding

When giving an explanation of your partner's call you are required to give the full *systemic* meaning of the call (including any negative inferences and special partnership understandings, but not anything you can deduce from knowing your own hand or that a new partner could deduce from general Bridge knowledge).

For example a 4D bid might be explained as "first round control in Diamonds and denies first round control in Clubs" or a 1NT bid might be explained as "6-12 points" (without having to say it denies a four-card Major).

Section 9.3 of the regulations says that merely naming a convention (e.g. Michaels, Lebensohl, etc.) is not an acceptable explanation.

If there is no partnership agreement say "Undiscussed". If you cannot remember the agreement, call the Director. In either case do *not* offer statements like "*I take it to mean...*" or "*I'm treating it as...*" as such statements create unauthorised information for your partner.

#### **Unauthorised Information**

If your partner creates unauthorised information it is not the end of the world, but the key restriction on you is contained in Law 16B1a:

• A player may not choose a call or play that is demonstrably suggested over another by unauthorised information if the other call or play is a logical alternative.

If your opponents may have done this, call the Director. It helps train players and Directors and, if your side is damaged, the Director can adjust the score.


#### A USEFUL CONVENTION

## Wendy Mitchell

Playing with Henrietta Hohnen in the Monthly Shield on Wednesday 2/4, I was South and opened 1D.

Partner's hand is now worth at least 19 TPs. She now bid 4D = 'Minorwood'

This asks for Keycards in the same way as RKC Blackwood, but keeps the level of bidding lower.



My replies are:  $4H(1^{st} step) = 1 \text{ or } 4$ 

 $4S (2^{nd} step) = 0 \text{ or } 3$ 

 $4NT (3^{rd} \text{ step}) = 2 \text{ without the Queen}$  $5C (4^{th} \text{ step}) = 2 \text{ with the Queen}$ 

I made a mistake and answered 4NT, when I should have replied 5C. My 2 controls must be SA and HA as North as CA and DA and DK. Henri then bid 6D and I made 12 on the lead of D10. If I had answered correctly, she may have bid 7D, but then I would need to have found the winning line of play.

## Can you find it?

4 other pairs found their way to 6D, all making 12.

2 were in 3NT, making 12, but this can be kept to 11 – how?

1 pair bid 5D, and 3 were in 2D or 3D, all making 12.

1 pair managed to make 13 tricks but sadly was only in 3D.
